Illustrations of dinosaurs now commonly show feathers. Is this based on good evidence? A generation ago archaeopteryx was touted as a transition from dinosaur to bird. Once it is believed that dinosaurs are the ancestors of birds, it would make sense that feathers may have appeared long before they had any relation to flight. Are scales and feathers just variations of the same thing?

Have you considered...

...Finally! The 159-year-old debate was settled in 2020! In the same guarry that "Archie" the Archaeopteryx was found, a fossil feather was found. Evolutionists had considered that the feather belonged to a dinosaur. If it did, this would fit nicely the evolutionist's narrative of dino-to-bird evolution. But whose feather was it really, a bird or a dinosaur? Using a specialized type of electron microscope, researchers studied the nine attributes of the feather; they surmised that it was indeed a feather and it was specifically a flight feather called a primary covert feather. Scientists also examined 13 other Archeopteryx fossils, three having well-preserved primary coverts feathers. Then scientists overlaid the feather on top of the archaeopteryx's wing, and it fit perfectly. Not only that, scientists were able to discover microscopic pigment structures (melanosomes) in the feather which revealed the color of the feather- entirely matte black.

This debate is over, the feather belonged to a bird called Archeopteryx. No dino-to bird evolution! Just as God said in the Scriptures, He created birds to be birds and dinosaurs to be dinosaurs. No evolution here!

TCCSA's STATEMENT OF BELIEF

Last month we updated you on the past year and what we have in store for 2023 but how many of you have been coming to TCCSA meetings for more than 10 years? 20 years? Over 25?


